# Med-Or Foundation: 3 years of activity 2021-2024

## **Med-Or's mission**

The Med-Or Foundation was created in the Spring of 2021 with the aim to consolidate relations between Italy, Europe, and the countries of the Broader Mediterranean – an area that spans the Mediterranean, the Sahel, the Horn of Africa, and the Red Sea ("Med"), as well as the Middle East ("Or") – by promoting constructive dialogue and international cooperation through cultural initiatives, research, and scientific projects.





Med-Or, in its three years of activity, has supported initiatives of public diplomacy and the development of projects in the fields of higher education and professional training, through the financing of scholarships aimed for students from all and any Mediterranean countries. It also undertakes joint research activities with relevant international think tanks and research institutes to develop new

prospects for cooperation as well as scientific and training projects. In its work the Foundation involves individuals and professionals with great national and international experience in the institutional, industrial and academic fields.



# **How Med-Or is organized**

The Foundation is composed by various organs, each with specific functions and skills: the **Board of Directors** with 11 members; the **Board of Auditors** with three members; the **Strategic Committee**; the **Supervisory Body** with three members; the **Scientific Committee** with 42 members, including 16 Rectors from important Italian universities.

Moreover, the Foundation is enriched by an **International Board**, the body reflecting Med-Or's international projection.



The International Board is composed by 32 leading figures from the international political, diplomatic and academic spheres; coming from various countries in the Mediterranean and Euro-Atlantic areas, such as Algeria, Bahrain, Burundi, Egypt, Ethiopia, France, Germany, Greece, India, Israel, Jordan, Kenya, Lebanon, Malta, Morocco, Mauritania, Niger, North Macedonia, Qatar, Saudi Arabia, Somalia, Spain, Switzerland, Tunisia, Turkey, UK, United Arab Emirates, USA, Zambia.

## 3. Research and Higher Education Programs

The Foundation promotes Higher Education initiatives, educational programs and research projects. In three years around **600 scholarships** have been awarded to students from various Mediterranean and African countries. In the field of Higher Education, Med-Or has endorsed training programs in different fields, financing scholarships for Master's degrees, specialization courses, and for Doctoral and post-doctoral research grants.

# 4. Research projects and strategic analysis projects

- Predictive analysis and research's special projects in collaboration with the Italian Government Presidency of the Council of Ministers and the General Director for public and cultural diplomacy of the Italian Ministry of Foreign Affairs
- May 2023 The War in Ukraine and the Mediterranean Nexus, related to the strategic, economic, security and foreign politics ramifications of the Ukrainian War, discussed during the seminar organized with the German Marshall Fund, the Compagnia di San Paolo, the Policy Center for the New South and Alexander Philon Fund for the Transatlantic Partnership, as part of the 23<sup>rd</sup> edition of the Mediterranean Strategy Group
- September 2023 Prospect for Saudi-Iran Relations. Implications for the Region and the International System, related to the Saudi Iran relations, concluded with a seminary in collaboration with the International Institute for Iranian Studies
- October 2022/June 2023 Research on Cooperation between the UAE and Italy/UE, study on Italy (Europe) UAE (Gulf) political, economic, and cultural relations with a focus on energy, space, digital connectivity, defense, and food security. The main results have been discussed in the seminar "New Horizons for cooperation between Italy and the UAE", held in Rome, which was attended by Italian experts from think tank, industrial world and finance, influential academic figures from UAE, Italian and Emirati



diplomats. Moreover, the main points of the discussion have been summarized in the document "A new beginning in the Italy – UAE relations", which has been sent to both the Italian President of the Republic, to the president of the Council of Ministers, the Government, and the UAE Presidency.

In June 2023, a second seminar "Strengthening Italy-UAE Cooperation" has concluded the project with a dialogue between Italian and Emirati experts related to the Italian - UAE relation on Africa, energy transition and its future



- July 2023/May 2024 Digital Geopolitics: research project in collaboration with Center for International and Strategic Studies (CISS) of the Luiss Guido based in Rome, in the framework of the "Geopolitics and Technology. New paradigms of development: challenges, security and democracy" call for proposals issued by the Compagnia di San Paolo Foundation within the Mission "Fostering international opportunities" of the *Planet Goal*. The project plans the production of 11 research papers from Italian and International students. The objective is to study how international relations are changing due to the emergence of new technologies which could influence digital politics. At the end of the project, the final conference scheduled on May 2024 at Luiss Guido Carli University will discuss the main results and involve the main national institutional stakeholders to reinforce the related ideas in the Italian arena
- October 2023 "The Silent Enemy: Presence and Evolution of the Jihadist Threat in the Broader Mediterranean", first Med-Or Foundation's Special Report authored by Andrea Manciulli, Med-Or's Director of Institutional Relations, analyzing the state of play of threats linked to terrorism and jihadist radicalism in the geopolitical and geographical space of the Broader Mediterranean. The report has been presented on the 5<sup>th</sup> of October 2023 at Luiss Guido Carli University in Rome



March 2024 - "The crisis in the Red Sea and the implications for Italy", second Med-Or Special Report authored by Umberto Tavolato, Med-Or Special Projects O.U Director, furnishing a detailed analysis of the situation of the Red Sea, of the Gulf of Aden and of the wider Horn of Africa context. The report has been presented on March 27<sup>th</sup>, 2024, at Med-Or's headquarter, in the context of the Workshop on "The crisis in the Red Sea and the implications for Italy"
